Nancy F. Marino Prize

Early career scholars/graduate students: submit your essay on a topic in Hispanomedieval Studies to be considered for the Nancy F. Marino Prize.

The Nancy F. Marino Prize honors the contribution of Professor Marino to the profession, in particular her devotion and dedication to the many colleagues and students in Hispanomedieval Studies she mentored and inspired in her role as a founder of IMANA and as facilitator for the field each year at the International Congress on Medieval Studies at Kalamazoo. The winning paper is determined by a panel of judges that is selected annually by *La corónica* and recognizes excellence in scholarship in the field of Hispanomedievalism to an essay of outstanding quality addressing any topic in Hispanomedievalism accepted for the upcoming annual Medieval Congress at Kalamazoo. The early career scholar whose essay is chosen will be honored at the annual IMANA banquet at the conference.

Eligibility

All early career scholars (who have received their PhDs in the last 4 years) and any student enrolled in an MA or PhD program at conference time who will present papers at the International Congress on Medieval Studies at Kalamazoo are invited to compete for the prize for the best paper by a junior scholar of Hispanomedieval Studies at the conference. The winner will receive \$1000 and will be invited to expand the winning paper and submit it for consideration for publication in *La corónica* (http://www.lacoronica.org), a refereed journal published every spring and fall by the MLA
Forum for Medieval Iberian Literatures, Languages, and Cultures and devoted to Hispanomedievalism in its broadest sense.

Submit papers electronically as attachments (Word or PDF) via Google form (https://goo.gl/forms/rowHSonRSSyOVdaJ3). Papers must be received by April 15, 2020. Paper should be in the form actually to be delivered at the meeting (not a longer seminar paper on which the paper is based). The paper submission should include a cover page with the following information: title of the paper, name, academic affiliation, and email address. Please do not submit a handout or Powerpoint. All quotations should be included in the body of the paper and a Works Cited list provided at the end. While formatting changes, correction of typos, and the addition of a Works Cited page are acceptable, changes to the substance of the argument are not.
